



Terms and conditions of the “Inner Radiance” exhibition

By submitting artwork for consideration in the "Inner Radiance" exhibition hosted by Neural Nexus, you agree to the following terms and conditions:

1. **Legal Responsibilities:** Neural Nexus is not responsible for any legal claims, disputes, or liabilities arising from the content of submitted artworks or interactions among participants. Artists are responsible for ensuring that their submissions comply with all applicable laws and regulations.

2. **Intellectual Property Rights:** Artists retain full ownership and intellectual property rights to their submitted artworks. By submitting artwork for consideration, artists grant Neural Nexus a non-exclusive, royalty-free license to use, display, and reproduce the artwork for promotional purposes related to the exhibition. Neural Nexus will always credit the artist when displaying or promoting their work. Any use of the artwork outside the scope of the exhibition requires prior consent from the artist.

3. **Community Guidelines:** Neural Nexus is committed to creating a positive and respectful virtual environment. Harassment or inappropriate behavior, including but not limited to discrimination, hate speech, or any form of misconduct, will not be tolerated. Participants engaging in such behavior may be subject to removal from the exhibition and related events.

4. **Confidentiality:** Participants agree to maintain the confidentiality of any proprietary or sensitive information shared by Neural Nexus, its curator, president, or affiliated artists during the course of the exhibition. This includes, but is not limited to, curatorial plans, exhibition logistics, and any other non-public information. Unauthorized disclosure of such information is prohibited.

5. **Data Protection:** Neural Nexus will handle all personal data provided by artists in accordance with applicable data protection laws. Personal data will be used solely for the purposes of the exhibition and will not be shared with third parties without the artist's consent.

6. **Exhibition Duration:** The "Inner Radiance" exhibition does not have a specified end date. It will continue to evolve and provide a platform for artistic exploration.



7. **Exhibition Decisions:** The selection of artworks for the exhibition is at the sole discretion of Neural Nexus. While striving for transparency and fairness, decisions are final. Neural Nexus does not provide feedback on individual applications or disclose the selection criteria.

8. **Artistic Venture Information:** Neural Nexus is a product of an artistic thesis, and the performance and exhibition "Inner Radiance" will be evaluated, showcased, and analyzed based on the participation of individuals in the inauguration. Your engagement contributes to the ongoing assessment and development of this artistic venture.

9. **Technical Issues:** Neural Nexus is not liable for any technical issues that may arise during the submission process, exhibition, or related events. This includes, but is not limited to, website malfunctions, server disruptions, or other unforeseen technical difficulties.

10. **Spatial.io Affiliation:** Neural Nexus does not have any formal alliances with Spatial.io, the platform hosting the "Inner Radiance" exhibition. Neural Nexus is not responsible for the regulations or policies implemented by Spatial.io. Participants are encouraged to familiarize themselves with Spatial.io's terms and conditions.

11. **Digital Art Size and Adaptation:** Neural Nexus may not be responsible for variations in the size or presentation of digital art pieces when shown in Spatial.io. While efforts will be made to adapt to the artist's specifications, if those specifications are unclear, not feasible, or do not align with the curatorial plan, Neural Nexus will place the artwork in a manner deemed most suitable for optimal presentation and visual impact. If the final curatorial proposal differs from the artist's initial vision, Neural Nexus will notify the artist. The artist will have the option to request the withdrawal of their artwork up to 2 weeks before the exhibition's inauguration. Such requests must be made in writing.

12. **Additional Features for the Metaverse:** If artists choose to include additional features such as textures, movements, or interactivity in their artwork, these will be subject to feasibility and additional costs. Neural Nexus will discuss these options with the artist after the initial review. Any additional features incorporated will be at the artist's expense and require prior agreement.

13. **Virtual Interview Participation:** Participation in a virtual interview is optional. Artists who express interest will be contacted with details. Neural Nexus is not responsible for the scheduling or any technical issues related to the virtual interview.



14. Handling and Deletion of Submitted Files: All files submitted as part of the application process for the "Inner Radiance" exhibition will be stored on Neural Nexus's servers for the duration necessary to conduct the exhibition and related review processes. Artists acknowledge and agree that files will be stored only for the time required to facilitate the exhibition, including review and presentation. After the conclusion of the exhibition and any necessary post-exhibition activities, Neural Nexus will delete all submitted files from its servers. Neural Nexus will not be able to retrieve or provide access to any files once submitted, even before they have been deleted. Artists cannot make any claims or requests regarding the return or access to their files once they have been deleted. By submitting their files, artists consent to the temporary storage, use, and eventual deletion of their files as outlined in this clause.

15. Insurance and Liability: Neural Nexus is not liable for any damage or loss of artworks during the exhibition process, including technical issues or failures within the virtual environment. Artists are responsible for ensuring that their artwork is adequately insured if necessary.

16. Indemnity: Artists agree to indemnify, defend, and hold harmless Neural Nexus, its affiliates, officers, directors, curators, president, employees, agents, and other participating artists from and against any claims, liabilities, damages, losses, or expenses (including reasonable legal fees) arising out of or related to the content of their submitted artworks, their participation in the exhibition, or any breach of these terms and conditions. This includes any claims of intellectual property infringement or other legal disputes arising from the artwork or its use.

17. Artistic Freedom and Discretion: The curator of Neural Nexus reserves the right to interpret and present the submitted artworks in a manner that aligns with the exhibition's overall theme and vision. This may include, but is not limited to, altering the placement, context, or format of artworks. Artists acknowledge that the curator's decisions are final and agree to participate under these terms.

18. Personal Non-Liability: The president, curator, and any associated artists of Neural Nexus, acting in their official capacities, shall not be held personally liable for any claims, damages, or liabilities arising out of or in connection with the exhibition. Any legal actions or claims against Neural Nexus will be directed solely towards the organization as an entity.



19. **Right to Modify or Cancel:** Neural Nexus reserves the right to modify, postpone, or cancel the exhibition at any time for any reason, including but not limited to unforeseen circumstances, technical issues, or changes in the curatorial vision. In such cases, Neural Nexus, its curator, president, and any affiliated artists will not be held liable for any damages, costs, or losses incurred by participants as a result of such modifications or cancellations.

20. **Limitation of Liability:** Neural Nexus, including its curator, president, and any affiliated artists, shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in connection with the exhibition, participation, or any services provided. This includes, but is not limited to, damages for loss of profits, goodwill, use, data, or other intangible losses, even if Neural Nexus has been advised of the possibility of such damages.

21. **Force Majeure:** Neural Nexus shall not be liable for any failure or delay in performance due to circumstances beyond its reasonable control, including but not limited to natural disasters, technological failures, or other unforeseen events.

22. **Dispute Resolution and Jurisdiction:** Any disputes arising out of or related to the exhibition or these terms and conditions shall be resolved through good-faith negotiations. If a resolution cannot be reached, the dispute shall be submitted to binding arbitration in The Netherlands. The laws of The Netherlands shall govern these terms and conditions, without regard to its conflict of laws principles. Any disputes arising from these terms will be subject to the exclusive jurisdiction of the courts in The Netherlands.

23. **Amendments:** Neural Nexus reserves the right to amend these terms and conditions at any time. Artists will be notified of any changes via email or through the Neural Nexus website.

24. **Participation Fee:** Participating artists are required to pay a non-refundable participation fee as part of the exhibition process. Neural Nexus does not offer refunds for any reason, including but not limited to the artist's withdrawal, technical difficulties, or failure to meet exhibition requirements. Artists must understand that the participation fee is non-refundable even if their work is ultimately not selected for the exhibition.



25. **Scholarship Option:** Neural Nexus understands that some artists may face financial hardship and therefore offers a limited number of scholarships to cover the participation fee. To apply for a scholarship, artists must select the appropriate option in the application form. Scholarships are awarded based on demonstrated financial need and the quality of the submitted artworks.

Scholarships only cover the participation fee; no additional financial support is provided. Scholarships are not guaranteed and are awarded at the sole discretion of Neural Nexus, based on availability and eligibility. Recipients will be notified of their scholarship status via email. If an artist is not awarded a scholarship, they must still pay the entry and participation fees in order for their application to be reviewed and considered for participation.
